6. Applicants should be proficient in written and spoken English;
7. Successful applicants interested to be accommodated in the institute hostels shall pay TZS. 200,000/= per year prior application through prescribed forms.

1. Basic Technician Certificate in Forest Industries Technology - One Year ()

Admission requirement:

The applicant must have at least four passes (two passes must be of science subjects, i.e. (Biology or Chemistry or Geography or Physics or mathematics) and two passes in non-religious subjects. Pass in English is an added advantage.

OR

Certificate in Secondary Education from other countries with passes in science subjects and translated by NECTA.

2. Technician Certificate in Forest Industries Technology – One Year ()

Admission requirement:

Admissions to the programme will be to a person who successfully has completed Basic Technician Certificate in Forest Industries Technology or relevant field or form six level who has passed in science combination subjects with at least one principal and subsidiary pass.

3. Ordinary Diploma in Forest Industries Technology - One Year ()

Admission requirement:

Admission to the programme will be open to holders of NTA Level 5 in in Forest Industries Technology or relevant field.

Successful applicants will be required to pay training fee as follows:

- (i) Basic Technician Certificate students will pay TZS 930,000.00 per year.
- (ii) Technician Certificate students will pay TZS. 1,100,00.00 per year.
- (iii) Ordinary diploma students will pay TZS. 1,220,000 per year.

NOTE: Training fee can be paid in installment basis i.e., half of the total fee at the beginning of each semester
